



## *Regulations of the photo contest*

### *"AMBER INSPIRES"*

*Amber has always been with us. For years has been inspiring artists and designs were a sign of times and trends. Have we seen everything? Was this material shown in all possible ways? We call everybody involved in photography to present their vision inspired by amber.*

**The competition is organized by the Association of Goldsmithing Artist in Poland and Muzeum Nadwiślańskie in Kazimierz Dolny.**

**The partners of the competition are: Amberif - International Amber Fair and International Amber Association.**

**Conditions of participation:**

- 1. The contest is open to all adults who, by September 1, will send their work to the following address: *prezentacje@stfz.pl* in the title of the message entering the PHOTO COMPETITION.**
- 2. The content should include: name and surname, correspondence address, e-mail address and the author's phone number.**
- 3. Each participant may submit no more than three photographs about amber or amber inspired to the competition.**
- 4. The competition photo should be of a quality enabling potential use in printing, a minimum of 2000 pixels in the long side of the photo, and can not be marked with any watermarks and / or other notes identifying the author, etc. Saved in the jpg file in 300dpi resolution.**
- 5. The Competition Participant declares that he / she is entitled to full copyright rights necessary for publishing photos in the catalog, press, television, the Internet and other forms of event documentation for promotional purposes.**
- 6. If the image of others is used as part of the application, the participant undertakes to have the consent of persons presented in these materials to disseminate their image in the catalog, press, television, the Internet and other forms of event documentation for promotional purposes.**  
**The Contest Participant is obliged to repair the problem that the Organizer may suffer due to possible claims of other persons associated with copyright and any other rights to photos and images.**

**Entering the Application for participation in the Competition is the consent to irrevocable and unpaid use of the image of the person or persons shown on the submitted Competition Picture and to repeatedly use them, without the need to confirm them each time.**

**JURY:**

- 1. The jury's deliberations will be held on September 15, 2018 at the Muzeum Nadwiślańskie in Kazimierz Dolny.**
- 2. The composition of the jury will be announced at a later date.**
- 3. The jury will qualify the works in accordance with the regulations and will award prizes and mentions.**

**4. The jury will pay attention to the compliance with the theme of the competition and the original interpretation**

**5. The jury is obliged to substantiate its verdict in writing.**

**6. The jury's verdict is final.**

**7. Until the official announcement of the results of the competition, the jury's verdict is secret.**

**8. The list of artists qualified for the exhibition will be announced by September 30, 2018 at [www.mnkd.pl](http://www.mnkd.pl)**

#### **Settlement of the competition:**

**1. The announcement of results and awarding of prizes will take place on October 13, 2018 during the vernissage of the exhibition at the Muzeum Nadwiślańskie in Kazimierz Dolny.**

**2. The list of the awarded and mentioned artists will be published on the websites [www.stfz.pl](http://www.stfz.pl) and [www.mnkd.pl](http://www.mnkd.pl)**

**3. Works qualified for the exhibition will be presented from October 13, 2018 to December 9, 2018 at the Muzeum Nadwiślańskie in Kazimierz Dolny, and then at other locations throughout Poland.**

**4. Qualified works due to the next planned exhibitions will remain at the disposal of the organizers for three years. Then, by the end of January 2022, they will be sent back to the address given in the application form at the expense of the author.**

**5. Information about prizes and mentions will be provided at a later date.**

**6. In accordance with applicable regulations, those who have been rewarded in cash or in material prize are obliged to pay a flat-rate income tax to the treasurer STFZ in the amount of 10% of the total reward received (if the value exceeded PLN 760) at the time of receipt.**

#### **Publishing:**

**The exhibition will be accompanied by a catalog of works qualified for the exhibition. Each of the authors qualified for the exhibition will receive one copy of the catalog.**

#### **Final Provisions:**

**1. Members of the jury, competition commissioner and prize funders do not take part in the competition. They can attach their work to the exhibition and catalog outside the competition.**

**2. This regulations are the only document defining the rules of the Competition.**

**3. The Organizer is entitled to change the provisions of the Regulations, provided that it does not affect the conditions of participation in the Competition. This applies in particular to changes in the dates of individual competition activities and changes to the Specification of Awards. The amended provisions of the Regulations enter into force upon their publication on the Competition Website.**

**4. The organizer establishes the address for all correspondence related to the competition**

**and the person authorized to correspondence, the commissioner of the competition Michał Fatyga.**

**5. By submitting a work to the competition, the participant declares that has read the regulations and accepts them.**
